- 1. This tournament is open to all USBC Youth Members. Youth bowlers are required to show their USBC card or temporary at check in.
- 2. Entering Average: Entrants will use averages in the following order:
  - Highest 2024-2025 USBC certified fall/winter book average of at least 12 games .
  - If no 2024-2025 USBC book average, current average of at least 12 games as of November 1, 2025 will be used.
  - According to USBC Rule 201c, a bowler with averages established on a standard/house condition and on a Sport and/or Challenge conditions, no conversion of averages is required and the bowler would enter with the highest average.
  - USBC Rule 319a (2) 10-pin rule does NOT apply.
  - Failure to report an accurate average that results in a divisional change may result in disqualification.
- 3. Handicap will be 100% of 220. Average divisions will be as follows:

- 4. Teams will consist of 4 members. Bowlers may be participate in the Team & Doubles events more than once. At least two (2) of the bowlers must be different in the Team event and one (1) in the Doubles event. You can only participate once in the Singles event. For All Events your first scores in each event will be used.
- **5.** Entry fee is \$25.00 per person per event. Lineage/expenses is \$15.00, scholarship/prize fund \$10.00. Scholarship awards will be given on a 1:5 ratio in each division (SMART Account #9009). Any added scholarship money will be pro-rated per division. First place winners in each division and scratch all events will receive a plaque at the SSUSBC Annual Awards Banquet. **\$4,000.00** will be added from **SMART unassigned funds for scholarships.**
- 6. Entries close at 4:00 PM on November 6, 2025. Squads are filled on a first come first serve basis.
- 7. Tournament Managers must be notified of any changes (substitutes) at check in. The line up that you submit will be the line-up at the start of each event.
- 8. All bowlers **MUST** check in dress code compliant at least 30 minutes prior to squad start time. Dress attire must be neat, clean and proper fitting. Collared shirts or USBC or SSUSBC official youth jersey and slacks, Bermuda shorts, capris, skirts or skorts must be worn. Skirts and skorts must be to the end of fingers when arms held down to side. Tournament Director must approve any/all exceptions. Tournament Director's decision is final.
- 9. If there is an error in scoring, contact a tournament official immediately. All other conflicts with the general playing rules must be made to the tournament director no later than 30 minutes after completion of each event that the conflict was in. Any protest must be confirmed in writing to the South Sound USBC within 72 hours after completion of the tournament. Each protest under this rule must be specific in itself.
- 10. Ties shall be resolved with a 9th and 10th frame roll off with no practice balls, unless there has been a delay of 15 minutes or more.
- 11. Electronic Devices may be used on the concourse area only.
- 12. Coaching during competition is encouraged on the concourse area only, even with a RVP Badge. Coaches are not allowed to sit or coach in the settee area during competition. This can result in the coach being removed from the center and the bowler being disqualified.
- 13. Misconduct/Poor Sportsmanship on or off the lanes during the competition by either the bowler or spectators will not be tolerated. This will result in disqualification from the tournament and forfeiture of entry fee & position.
- 14. All USBC Rules will be observed.
